## 2023-2024 Parent Non-filer Form

The U.S. Department of Education and/or Vermont State University selected your student's application for "Verification". One of the items the central processor selected to verify on your application is your filing status. The law says we have the right to ask for this information. If there are differences between your application and this statement, we will send corrections electronically to the U.S. Department of Education. If corrections are made, you will then receive an updated Student Aid Report (SAR) from the Central Processor (CPS). This may result in an adjustment to your estimated financial aid. *Financial Aid payments will not be posted to your Student's Account until all verification requirements have been met and the necessary corrections have been made*.

## What you and your parent should do:.

- 1. The instructions and certifications below apply to **each parent and/or stepparent included in the household**. Complete this form if parent1 and/or parent2 have not filed, will not file, and <u>are not required</u> to file a 2021 income tax return with the IRS.
- 2. Submit an IRS Verification of Non-filing letter dated on or after October 1, 2022 that indicates a 2021 IRS income tax return was not filed with the IRS for each parent non-filer. This letter is obtained by checking box 7 on the IRS Form 4506-T, Request for Transcript of Tax Return, and mailing it to the IRS. This request cannot be made online. If you have tried and are unable to obtain an IRS Verification of Non-filing letter from the IRS a signed statement certifying that the individual attempted to obtain confirmation of non-filing from the IRS or other relevant tax authority and was unable to obtain the required documentation is also acceptable.
- 3. Send this completed form and the IRS Verification of Non-filing letter to the address above.
- 4. We may need information on other verifiable items. Please check your 2023-2024 Financial Aid Document Status on the Portal and submit all other incomplete items.
- 5. If you have any questions, please call our office at (802) 468-6070. An incomplete form will be returned to you, which will delay your financial aid.
